

SOUTH JORDAN CITY **NEIGHBORHOOD CLEAN-UP PROGRAM**



South Jordan City offers its residents the Neighborhood Dumpster Clean-Up Program. Neighborhood associations, individuals or other volunteer groups may schedule delivery and pickup of a 30 cubic yard roll-off dumpster for their neighborhood or individual clean up projects. The City will provide the dumpsters at a cost of **\$39.00 a day or \$78.00 a weekend**.

1. Dumpsters are for residential use only! No business or commercial contractors located or working in the City are to use this service. Violators will be cited and prosecuted!
2. Tires, refrigerators, air conditioners, drum containers and batteries shall not be deposited in the dumpsters. Contact the City for Special Service Waste Pick-up regarding these items. Additional fees will be assessed for disposal of such items.
3. Toxic, hazardous or flammable materials, (pesticides, herbicides, solvents, chemicals, paints, motor oil, gasoline, etc.) shall not be deposited in the dumpsters. Information on disposal of household hazardous wastes may be obtained by calling the Salt Lake Valley Health Department at 313-6697 or by contacting the Trans Jordan Landfill at 569-8994.
4. Dirt, Manure, and Rock Materials shall not be deposited in the dumpster.
5. Dumpsters shall not be overloaded. Dumpsters shall not be filled above the sidewalks. Residents using the dumpsters will be required to clean up any spillage caused by overloading. The City will not clean up debris left on the ground. If materials are deposited over the weight limit an additional fee **WILL** be assessed.
6. Dumpster pick up will be rejected if any of these rules are violated, with the responsibility of the renter to empty the dumpster.

The undersigned agrees to abide by the above rules and to the following:

- A responsible adult from your organization or residence will monitor the dumpster to ensure compliance with the rules.
- The undersigned for himself/herself and others represented, hereby releases South Jordan City and it's employees from any and all liability for damages resulting from equipment or personnel being on private property to deliver or remove the dumpsters and from any injuries incurred by individuals using the dumpsters.

AND HOLD HARMLESS AGREEMENT

By my signature below, I acknowledge that South Jordan City has informed me that the movement of City trucks, vehicles, containers, and equipment onto or off of my property may cause damage to the property due to the weight and/or movement of the trucks, containers, or equipment.

By executing this Authorization for Entry Onto Property and Hold Harmless Agreement in the space below, I am authorizing South Jordan City to enter my property at my request for the purpose of placing and moving a dumpster container onto or off of my property. Additionally, by signing below, I agree to release, indemnify, and hold harmless South Jordan City or it's employees from any and all claims, liabilities, causes of action, expenses (including attorneys' fees), and damages to the property resulting from the placement and/or movement of the vehicle, and container on my property.

For purposes of the Authorization, the term "property" is defined to include your driveway and surrounding areas and structures.
