## South Jordan Field Request Details

The City has certain public recreational facilities available for use by the public. Tenant desires to utilize facilities located within the City for the purposes set forth and the parties are willing to partner with each other to provide youth recreational sports to South Jordan residents and others.

South Jordan City programs are recreational sports programs funded, operated and supervised by the City.

Contracted programs or Program Agreement Users include recreational sport programs operated by sports leagues that enter into a Facility / field Use Agreements with South Jordan City. Upon execution of this Agreement by the Tenant, the Tenant shall provide copies to the City of any and all occupational licenses, competency cards, or certificates necessary for the performance of the Tenant's programs.

All Program Agreement Users will be required to independently comply with H.B. 204 "Protection of Athletes with Head Injuries" and certify compliance.

For the use of the City's facilities, the Tenant agrees to pay compensation to the City in accordance with the South Jordan City Fee Schedule. Said fees will be paid per season for the registration and enrollment of any person who registers with the Tenant for the programs.

The Tenant shall purchase and maintain, at its own expense, general liability insurance to cover claims for damages because of bodily injury or death of any person or property damage arising in any way out of the programs performed by the Tenant under this Agreement. General personal injury and property damage liability insurance and automobile liability insurance with liability limits of not less than \$2,000,000 each occurrence and \$3,000,000 aggregate for the injury or death of person or persons and property damage.

All insurance coverage will be with insurer(s) approved by the City and licensed by the State of Utah to engage in the business of writing insurance. The City shall be named on the insurance policy as "additional named insured".
