GENERAL PURPOSE

Perform a variety of entry level skilled duties related to identifying, locating and marking City underground electrical utilities in accordance with Utah Blue Stake requirements.

SUPERVISOR

POSITION(S) SUPERVISED

ESSENTIAL JOB FUNCTIONS

Meet performance standards established with the employee’s supervisor.

Job attendance is required, except for authorized leave.

Operate a wide variety of light and heavy duty vehicles and equipment (including but not limited to pickup trucks, single & tandem axle dump trucks, road grader, front end loader, backhoe, and various road construction equipment).

Perform heavy physical labor related to streets, sidewalk and other infrastructure maintenance.

Participate in work zone safety procedures and follow safety principles when operating vehicles and equipment to reduce/eliminate accidents and injury.

Operate, clean, and maintain tools, vehicles and equipment to assure proper working order.

Take initiative to observe and report conditions throughout city (i.e. tilted stop sign, road debris, unauthorized use of fire hydrant) to ensure timely action for needed work is performed.

This position has been determined to be not eligible for remote work because all or a majority of the essential job duties must be performed onsite.

Perform other duties as assigned.

MINIMUM QUALIFICATIONS

1. Education and Experience:

Experience in a related field preferred

2. Special Qualifications:

Valid Utah Class D Driver License

3. Knowledge, Skills and Abilities:

Basic knowledge of machinery, materials, and methods of street light construction, safety standards related to road construction; hazards common to heavy equipment operation; equipment maintenance and repair; legal liabilities associated with street light construction and marking.

Knowledge of operating basic manual and power tools; the standard practices, methods, materials and tools necessary for roadway construction and marking utilities and the occupational hazards and safety precautions of road maintenance work.

Ability to perform physical labor; develop and maintain effective working relationships with co-workers and general public; tolerate weather extremes in the work environment; perform basic mathematical computations.

4. Working Conditions:

Tasks require variety of physical activities, generally involving muscular strain, such as walking, standing, stooping, sitting, reaching, lifting (40-60 lbs.), etc. Talking, hearing and seeing essential to the performance of the job. Daily exposure to weather extremes and seasonal conditions. Common eye, hand, finger dexterity exist. Mental application utilizes memory for details, verbal instructions, critical thinking. Frequent inner City travel required in normal course of job performance.
